## Pigs Eye, Red Rock Rd & Rail

**Overview:** On August 6 the Land Use Committee held its monthly meeting at which the Port Authority presented a plan to make the railroad's Red Rock Terminal safer for employees in the businesses there and loading/unloading more efficient and economical for the trains.

We found out that many of the folks in the community wanted to learn more about this plan, particularly in how it will impact Pig's Eye Regional Park in the short term and in the long term. To that end we held a community meeting on Tuesday, August 21 from 6:00 - 8:00 pm at Battle Creek Rec Center.

**The Meeting:** The meeting was well attended with over 70 people joining us. We had presentations by the Kathryn Sarnecki from the Port Authority who spoke about the plan to add the rail line across park land for safety and efficiency; and Mary deLaittre from the Great River Passage Initiative who spoke about the East Side River District (project 3) – which is a unique, complex, sensitive location. (Their presentations can be found on the website.) That was followed up by questions, comments and statements from the community.

Some of the topics related to rerouting the railroad across park land that were addressed were:

- Impact on Pig's Eye Regional Park and how that effects the existing plans that have been in the works for years
- Benefits to our community – are there any?
- How would diversity and equity be addressed
- Public access, water quality and habitat degradation
- Stewardship of our environment
- Safety of the employees that work in the area – this needs to be addressed and ensured (current rail practices block their access to work and access to emergency vehicles).

To be sure people had ample opportunity to comment there were comment forms available at the meeting and an online form was posted on the District 1 Council's website.

Council member Jane Prince continues to pursue this topic to gather more information before it comes before the city council. She is talking further with a number of varied and knowledgeable groups on all sides of the issue to learn more. She's also asking that the Port Authority to address the scope of the project and related issues.


